Introduction

The COVID-19 pandemic underscored digital access as a fundamental requirement for education, healthcare, employment, and civic participation, driving a nationwide movement to close the digital divide. California now has a once-in-a-generation opportunity to expand high-speed internet and digital access, thanks to federal funding from the Infrastructure and Jobs Act, allocated through the National Telecommunications and Information Administration (NTIA) and distributed to states.

In California, the effort is coordinated by the California Department of Technology (CDT) and the California Public Utilities Commission (CPUC). This funding supports the development of statewide goals, strategies, and action plans to bridge the digital divide. Central to this initiative is the Statewide Digital Equity Plan (SDEP), which outlines three high-level goals aimed at ensuring all Californians can fully participate and thrive in the digital age.

California Statewide Digital Equity Plan Goals

GOAL 1

All Californians have high-performance broadband available at home, schools, libraries, and businesses.

GOAL 2

All Californians can access training and support to enable digital inclusion.

GOAL 3

All Californians have access to affordable broadband and necessary devices.

In Santa Barbara County, nearly 8% of residents lack internet access, while many others experience slow connectivity, lack home computers, or lack the skills to use them. As a result, many community members are unable to fully participate in education, apply for jobs, stay connected with loved ones, or access telehealth services. This digital divide disproportionately impacts People of Color, Indigenous communities, low-income households, people with disabilities, rural residents, and older adults—widening existing inequalities.

At the request of Santa Barbara County, the Santa Barbara Foundation (SBF) formally launched the Santa Barbara County Digital Equity Coalition (DEC) to align efforts, convene partners, and secure a fair share of state and federal funding for digital inclusion initiatives.

Mission & Objectives

The Digital Equity Coalition works to close the digital divide across all communities in Santa Barbara County by aligning resources, strategies, and partnerships. As part of a broader statewide and national effort, the DEC assesses and strengthens local digital inclusion initiatives while coordinating with regional and state-level digital equity programs.

The coalition focuses on six key priorities:

- Affordable Broadband Access
- Device Access
- Digital Literacy
- Technical Support
- Empowering Content
- Countywide Leadership

Collaborative Leadership & Partnerships

The Santa Barbara Foundation (SBF) serves as the primary convener of the DEC, working in partnership with the Broadband Consortium Pacific Coast (BCPC) and approximately 70 representatives from various sectors, including education, healthcare, public housing, governance, and community resilience organizations.

Additionally, the Santa Barbara Foundation and the Santa Barbara County Association of Governments (SBCAG) have executed a Memorandum of Understanding (MOU) to define key priorities, track progress, and evaluate outcomes in pursuit of the Broadband for All initiative across Santa Barbara County.



TRACKING PROGRESS:

Key Focus Areas & Outcomes

The chart below outlines the Digital Equity Coalition's (DEC) primary focus areas, shown on the left in dark blue, alongside progress across 2023, 2024, and beyond, displayed in lighter blue. Each focus area represents a core pillar of the DEC's mission, with key outcomes that have been achieved by partner organizations highlighted in bold.



This visual representation demonstrates how the DEC and its partners are driving digital inclusion efforts over time—tracking advancements in affordable broadband access, device distribution, digital literacy, technical support, empowering content, and countywide leadership. The chart also highlights milestone achievements, illustrating the collective impact of coordinated initiatives in bridging the digital divide across Santa Barbara County.

Coordination and Advocacy

In 2023, the Digital Equity Coalition (DEC) Steering Committee, comprised of 15 partner organizations, guided the Coalition's activities, set strategic objectives, and ensured alignment with its key priorities.

At monthly Partners' Table meetings, more than 70 partners collaborated to share best practices, address challenges, and strengthen digital inclusion efforts. These meetings featured updates on funding opportunities, digital equity programs, statewide initiatives, and roundtable discussions with partners.

The DEC and its partners also actively participated in state-led initiatives aimed at securing substantial federal funding, which will be available in 2025 to support efforts to close the digital divide. Additionally, throughout 2023, the DEC helped low-income residents enroll in the Affordable Connectivity Program (ACP), which provided internet service discounts. This effort led to a 31% enrollment rate in Santa Barbara County, delivering direct cost savings to residents and advancing the Coalition's mission of equitable digital access.

SDEP/ BEAD Conference

DEC Focus Areas: Affordable Broadband, Countywide Leadership

In June 2023, the Economic Development Collaborative, Santa Barbara Foundation, Ventura County Community Foundation, San Luis Obispo Digital Equity Roundtable, California Department of Technology, and the California Public Utilities Commission hosted an in-person workshop to gather input on the State Digital Equity Plan (SDEP) and the Broadband Equity, Access, and Deployment (BEAD) Five-Year Action Plan. This workshop played a crucial role in collecting local feedback to help shape the Statewide Digital Equity Plan.

Held at the Santa Maria Veterans Memorial Community Center, the event brought together over 100 attendees from the tri-counties region (San Luis Obispo, Santa Barbara, and Ventura). Thanks to the coordination and leadership of the Digital Equity Coalition (DEC), Santa Barbara County achieved record participation at the workshop.

The event aimed to educate attendees on California's SDEP and BEAD plans while providing a platform for direct engagement with state officials. Participants contributed valuable insights that helped shape priorities for the \$42.45 billion BEAD funding program, ensuring that federal funds would be directed toward addressing digital inequities in the tri-counties region.





Digital Equity Bill of Rights LETTER OF SUPPORT

DEC Focus Areas: Affordable Broadband, Countywide Leadership

In September 2023, the Santa Barbara Foundation (SBF), on behalf of the Digital Equity Coalition (DEC), submitted a letter of support for the Digital Equity Bill of Rights (CA AB414 Reyes). The letter included the names and logos of 13 coalition partners.

The Digital Equity Bill of Rights is in alignment with California's Broadband for All initiative and the State Digital Equity Plan (SDEP). In October 2023, Governor Newsom signed the bill into law, making California the first state to officially recognize digital access as a civil right. This landmark legislation positions California as a national leader, advocating for digitally disadvantaged communities and unconnected households.

Draft State Digital Equity Plan **PUBLIC COMMENT**

DEC Focus Areas: Affordable Broadband, Digital Literacy Training, Technical Support, Countywide Leadership

In December 2023, the Draft State Digital Equity Plan (SDEP) was released. Integrating local input from the BEAD conference and other listening sessions, this plan would provide access to the Digital Equity Capacity Grant funded by the bipartisan Infrastructure Investment and Jobs Act (IIJA) of 2021. The Santa Barbara Foundation (SBF) carefully reviewed the draft SDEP. shared the analysis with DEC partners, and submitted a public comment on behalf of the DEC.

State Digital Equity Plan Subgrant **PUBLIC COMMENT**

DEC Focus Areas: Digital Literacy Training, Technical Support, Countywide Leadership

In September 2024, the California Department of Technology (CDT) announced that California's State Digital Equity Plan (SDEP) had received official approval from the National Telecommunications and Information Administration (NTIA). This approval unlocked \$70.2 million in federal funding to support the plan's implementation.

The funding will empower local organizations and communities to develop local digital equity plans, expand digital literacy training, and provide digital navigation services. To ensure transparency and inclusivity, stakeholders were invited to submit public comments on the SDEP subgrant program. This feedback process was designed to promote accountability and equitable fund distribution across California. The SDEP guidelines closely align with DEC's mission and objectives. In response, the Santa Barbara Foundation (SBF) submitted public comments on behalf of the DEC, offering recommendations for SDEP subgrants. These recommendations were also shared with DEC partners to support them in submitting their own public comments.

Best Practices & Program Updates

DEC Focus Areas: Countywide Leadership

Throughout 2023 and 2024, DEC partners collaborated to share progress, challenges, and best practices as digital inclusion practitioners.

Key takeaways from this collective effort included:



Building strategic partnerships to close funding and capacity gaps

The Affordable Connectivity Program (ACP) and Affordable Broadband

Leadership

The Affordable Connectivity Program (ACP) was a federal initiative that provided a monthly discount on internet service for eligible low-income households, aiming to improve access to wireless internet. In 2023, Santa Barbara County surpassed its goal of a 10% increase in ACP enrollments, achieving an 11.2% increase.


DEC Focus Areas: Affordable Broadband, Digital Literacy Training, Countywide

These partners facilitated enrollment and outreach events, developed partnerships and referrals, and provided one-onone assistance to support ACP enrollment. ACP Enrollment Specialist Trainings were conducted with support from the Broadband Consortium Pacific Coast and completed by the American GI Forum, Family Service Agency, and Lompoc Adult School. Data collection was conducted by the Guadalupe Broadband Survey (FSA), CommUnify, and UCSB.

The ACP program stopped accepting new applications and enrollments on February 7, 2024, with April 2024 marking the last month for enrolled households to receive full benefits. The DEC was notified early about this change and shared a list of alternate reduced-rate internet options with its partners for Santa Barbara County residents.

As the ACP program sunsets, affordable broadband access remains a barrier in the county. In response, the DEC is adapting its strategy to continue supporting affordable broadband by:

- Assessing and promoting low-cost internet options for key populations.
- Ensuring that internet access and digital literacy are integrated into success metrics across all partner efforts.
- · Identifying one-on-one technical support for residents to assist with access challenges.







Digital Literacy Training

DEC Focus Areas: Digital Literacy Training, Technical Support, Empowering Content

As part of the Statewide Digital Equity Plan (SDEP) development, the California Department of Technology created the Digital Equity Ecosystem Mapping Tool (DEEM). DEC partners contributed their program offerings through this tool, positioning Santa Barbara County as a top contributor to the DEEM data collection efforts. This data is publicly available on the SDEP website, allowing DEC partners to access and leverage it for their own initiatives.

Access to Technology Grant Pilot Program

DEC Focus Areas: Affordable Broadband, Internet-Enabled Devices, Digital Literacy Training, Technical Support, Empowering Content, Countywide Leadership

In 2024, the Santa Barbara Foundation became the fiscal agent for a California Department of Aging Access to Technology (ATT) grant, a pilot project aimed at developing Digital Navigators—individuals who support the entire digital inclusion process—to assist aging adults and adults with disabilities in gaining access to connectivity and devices for internet use.

Five DEC partners participated in this program:

- American GI Forum
- CommUnify
- Community Partners in Caring
- Family Service Agency
- Independent Living Resource Center

These partners collectively completed 980 hours of digital navigator training through the Community Tech Network (CTN), served 654 community members, and distributed 573 devices.

What sets this program apart is its sustainability — the focus is not only on immediate impact but also on long-term community benefits. By training local staff and volunteers, we ensure that valuable knowledge and resources remain within the community, fostering lasting change.

This project serves as a model, positioning the DEC to scale similar digital equity efforts across different sub-populations and regions in the county. During the grant period, the DEC also redesigned its countywide website, sbcdec.org, to facilitate resource sharing among partners, promote training opportunities, and provide access to technology resources for local communities.

ATT Impact: Keeping our Older Adults Connected



Martha, a 65-year-old retiree, had never used a tablet before and was initially hesitant to try. However, she decided to attend one of our classes, where she learned the basics of tablet navigation - such as turning it on, connecting to Wi-Fi, and using essential apps.

As she progressed, Martha quickly gained confidence. She learned to send emails, browse the internet, and even video call her grandchildren. Martha went from feeling intimidated by technology to becoming an enthusiastic and capable user.

Looking Forward

Draft Santa Barbara County Digital Equity Plan

The Digital Equity Coalition (DEC) is ready to leverage data from our partnership table to identify areas of need and develop strategies for achieving our digital inclusion goals across Santa Barbara County. Through strong collaboration with our partners, we aim to align with key mission pillars—workforce development, healthcare, education, civic participation, and social justice. By utilizing strategic goals and objectives, we will define the priorities of the Digital Equity Plan and prepare ourselves to deepen countywide leadership in the prioritization of infrastructure plans.

Opportunities and Context of Digital Equity Efforts

The years 2024-2025 offer a rare opportunity to secure once-in-a-generation funding to close the digital divide, with significant support from federal and state agencies, as well as nonprofit organizations. The DEC is strategically positioned to secure sustainable funding for its ongoing work in underserved communities. By leveraging our countywide leadership role, we will continue to promote broadband access, adoption, and training through existing programs.

Our outreach strategies are designed to be multilingual, culturally responsive, and adaptable to the evolving needs of the community. This comprehensive approach enables the DEC to effectively tackle digital disparities while refining our strategies as digital literacy and access continue to improve across Santa Barbara County.


